Mr. CORNYN (for himself, Mr. BENNET, Ms. ERNST, and Mr. WARNER) introduced the following bill; which was read twice and referred to the Committee on _____

A BILL

To amend the Public Health Service Act to expand the capacity of the suicide prevention lifeline and mental health crisis centers.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Suicide and Crisis Out-
5 reach Prevention Enhancement Act”.

1 **SEC. 2. EXPANDING CAPACITY OF THE SUICIDE PREVEN-**
2 **TION LIFELINE AND MENTAL HEALTH CRISIS**
3 **CENTERS.**

4 Section 520E–3 of the Public Health Service Act (42
5 U.S.C. 290bb–36e) is amended—

6 (1) in subsection (b)—

7 (A) in paragraph (1)—

8 (i) by inserting “supporting and” be-
9 fore “coordinating”; and

10 (ii) by inserting “mental health” be-
11 fore “crisis intervention services”;

12 (B) by redesignating paragraphs (2) and
13 (3) as paragraphs (3) and (4), respectively;

14 (C) by inserting after paragraph (1), the
15 following:

16 “(2) increasing the capacity of the program and
17 crisis centers participating in the network to provide
18 suicide prevention and mental health crisis interven-
19 tion services to individuals seeking help;”;

20 (D) in paragraph (3), as redesignated by
21 subparagraph (B), by striking “and” after the
22 semicolon;

23 (E) in paragraph (4), as redesignated by
24 subparagraph (B), by striking the period at the
25 end and inserting a semicolon; and

1 (F) by inserting after paragraph (4), as re-
2 designated by subparagraph (B), the following:

3 “(5) improving awareness of the program for
4 suicide prevention and mental health crisis interven-
5 tion services, including by conducting an awareness
6 campaign and ongoing outreach to the public; and

7 “(6) establishing, standardizing, and maintain-
8 ing data collection and reports on racial, ethnic, geo-
9 graphic, socioeconomic, and other health disparities
10 to understand disparities in access to the program
11 and among individuals who are seeking help.”; and

12 (2) in subsection (c), by striking “\$7,198,000
13 for each of fiscal years 2018 through 2022” and in-
14 serting “\$50,000,000 for each of fiscal years 2022
15 through 2026”.

16 **SEC. 3. ENSURING CONNECTIONS AND ACCESS FOR LOW-**
17 **INCOME USERS.**

18 (a) TRANSMISSION OF CONNECTION.—A tele-
19 communications carrier (as defined in section 3 of the
20 Communications Act of 1934 (47 U.S.C. 153))—

21 (1) shall transmit all calls to 988 and the Na-
22 tional Suicide Prevention Lifeline to a caller’s local
23 crisis center; and

1 (2) if a local crisis center transfers such a call
2 to a local emergency, mental health, or social serv-
3 ices resource, shall transmit the call accordingly.

4 (b) PRE-PAID PHONE PLANS.—Calls to 988 and the
5 National Suicide Prevention Lifeline from phones with
6 pre-paid plans shall not count toward used minutes and
7 a telecommunications carrier (as defined in subsection (a))
8 shall not deduct minutes from a caller’s pre-paid phone
9 plan for such purposes.

10 (c) ENFORCEMENT.—A violation of this section shall
11 be treated as a violation of the Communications Act of
12 1934 (47 U.S.C. 151 et seq.). The Federal Communica-
13 tions Commission shall enforce this section in the same
14 manner, by the same means, and with the same jurisdic-
15 tion, powers, and duties as though all applicable terms and
16 provisions of the Communications Act of 1934 were incor-
17 porated into and made a part of this section.
