The Access Fund writes to express our strong support for the Gunnison Outdoor Resources Protection (GORP) Act. This well-balanced legislation effectively integrates appropriate conservation protections with recreation management designations, ensuring high-quality outdoor experiences while preserving the regional economy.

The Access Fund is America's national advocacy organization whose mission keeps climbing areas open and conserves the climbing environment. A 501(c)3 non-profit supporting and representing over 7 million climbers nationwide in all forms of climbing—rock climbing, ice climbing, mountaineering, and bouldering—the Access Fund has over 10,000 members and nearly 150 local affiliate organizations. Colorado is one of the Access Fund's largest member states.

The Access Fund has a long history of advocating for public lands, including our stalwart support for your CORE Act, which was developed through extensive community collaboration that is essential for effective and durable public land conservation and recreation management. We understand that the GORP Act was crafted similarly, with consultation from local stakeholders including the Gunnison Valley Climbers Association.

Climbing has been a longstanding activity in the Gunnison Valley, dating back to the 1970s. The region offers a range of climbing experiences, from world-class challenging routes to cliffs suitable for beginner climbers. As you know, fixed anchors are essential tools for climbers to safely navigate these climbing areas, allowing for greater public access to some of the most stunning vertical landscapes. However, if key climbing areas fall within a new wilderness designations, future climbing opportunities and the replacement of aging hardware could be severely restricted.

We greatly appreciate your adjustment of the East Cement Creek Wilderness boundary to exclude vital climbing zones, which are highly valued by the local community. These areas will still enjoy strong protections under other provisions of the GORP Act, while preserving the potential for ongoing route development. Thank you.

We commend you and your staff for your diligence in considering and accommodating various existing and historic uses, including rock climbing. The Access Fund stands ready to assist in advancing the GORP Act through Congress.

American Whitewater is proud to support the Gunnison Outdoor Resources Protection ("GORP") Act. The GORP Act will achieve proper management and protection of public lands in Gunnison County, including highly cherished whitewater rivers that support a robust recreation economy and sustain life in the surrounding landscapes.

American Whitewater is a national 501(c)(3) non-profit organization with a mission to protect and restore our nation's whitewater resources and enhance opportunities to enjoy them safely. American Whitewater represents the interests of river enthusiasts across the nation, including 50,000 supporters, 7,000 dues-paying members and 80 local affiliate club members. As conservation-minded whitewater recreationists, we place a high value on protecting naturally functioning river ecosystems, including their fish and wildlife, geomorphic processes, and potential to provide clean and safe drinking water.

Many of our American Whitewater members and supporters either live in Gunnison County or travel to the county to boat. The whitewater boating community in Gunnison County, in Colorado, and from across the country highly value the rivers and public lands in Gunnison County. The landscapes within the GORP Act include world renowned and locally treasured whitewater rivers, such as the East River, the Slate River, Daisy Creek (i.e., Poverty Gulch), the Taylor River, and Oh-Be-Joyful Creek. The Taylor River generates over \$4 million dollars through commercial rafting and the Grand Mesa, Uncompahgre, and Gunnison National Forest has recognized the high quality of the river recreational opportunities on many of these rivers. Some of these opportunities require motorized vehicle access, which currently exists, and once on the water, kayaking, rafting, paddle boarding, canoeing, and other forms of paddling is a low-impact, wilderness compliant, outdoor recreation activity, making these activities compatible with both the proposed Special Management Areas and Wilderness Areas in the GORP Act.

Oftentimes, whitewater recreation is overlooked by federal land managers even though it provides high quality outdoor recreation opportunities for locals and visitors alike. Unlike activities on trails and roads, there is not always evidence that whitewater boating is an existing activity and it is critical that whitewater resources on the GORP Act landscape are protected and managed for. We look forward to working with Senator Bennet, local stakeholders, and federal

land management agencies to ensure that whitewater recreation is properly managed for in the GORP Act landscapes.

American Whitewater appreciates your dedicated leadership to protect and improve management of our public lands through the GORP Act. We look forward to supporting you as you advance the GORP Act through Congress and we are dedicated to helping ensure that the subsequent management plans amendments for these areas are robust.

The Colorado Wildlands Project is proud to support the Gunnison Outdoor Resources Protection ("GORP") Act. The Colorado Wildlands Project works to protect wild public lands managed by the Bureau of Land Management (BLM). We are dedicated to the conservation, climate resilience, and equitable management of our public lands. We have spent several years conducting inventories of wildlands in western Colorado and working closely with partners across the Colorado Plateau to rally support for public land protections.

The Gunnison Basin is a remarkable region that showcases the diverse ecosystems and outdoor experiences that make Colorado unique. BLM lands in and around the region are home to some of Colorado's most important wildland values, including critical wildlife habitat, prized recreational opportunities, irreplaceable cultural resources, and healthy watersheds that serve local communities and the larger Colorado River Basin. The Colorado Wildlands Project works to maintain updated inventories of BLM wildlands on BLM lands across Colorado, and has identified numerous areas in the Gunnison field office worthy of protection as designated wilderness or similar protective management. BLM has identified over 81,000 acres of lands with wilderness characteristics in the Gunnison Field Office, and we strongly support the GORP Act's proposal to add permanent protections for some of these areas, either as designated wilderness or as other types of special management areas. In particular, we strongly support the proposed additions to the West Elk and Powderhorn Wilderness Areas, as well as the proposed increased protections for important BLM lands at McIntosh Mountain and Cabin Creek. Gunnison County contains irreplaceable BLM wildlands and we are supportive of the protections proposed for these BLM lands in this bill.

The Rocky Mountain Biological Laboratory (“RMBL”) supports the Gunnison Outdoor Resources Protection (“GORP”) Act. Located in Gothic, CO, RMBL provides logistical support for scientists and students, including access to living quarters, research laboratories, and protected research sites for one of the largest annual migrations of field biologists from across the United States and around the world. RMBL focuses on the importance of preserving and providing access to the unique historical data about the local ecosystems, mostly from and about public lands, that has been compiled over more than a century of research in and around Gunnison County. As scientists address ever more sophisticated questions about a dynamic world, RMBL is a vital resource for discovering nature’s fundamental ecological and evolutionary processes.

Gunnison County’s public lands play a critical role in the advancement of that science. A range of federal agencies, including the National Science Foundation, the Department of Energy, and the National Institutes of Health, collectively spend more than \$10 million annually for research that depends at least in part on fieldwork on and around public lands in Gunnison County. Collectively this research represents one of the nation’s largest financial investments in field research conducted in a single region. Because of the infrastructure support for this research, and the value of past research to future research, the importance of Gunnison County to the nation’s scientific portfolio is likely to increase. In addition to serving as a platform for investigating biological, hydrological, and geological processes, this research informs our understanding of food security, water quality and quantity, human disease, and air quality.

The value of research in the Gunnison Basin depends in large part upon access to a portfolio of ecosystem types on public lands. Research on public lands is managed within the context of multiple use and depends on thoughtful land management that includes long-term protections for research sites and the landscapes on which they often depend. Included are the many existing and proposed wilderness areas in an around Gunnison County, all of which contain significant features of scientific value. For these and many other reasons, access to and protection of public lands for scientific research should remain a critical part of public land management in Gunnison County. The GORP Act will significantly advance that kind of thoughtful land management, including through the designation of the Rocky Mountain Scientific Research and Education Area, an area around RMBL that includes an extraordinary density of important long-term research sites.

The Sustainable Tourism & Outdoor Recreation (STOR) Committee heartily endorses the Gunnison Outdoor Resources Protection (GORP) Act. The GORP Act is the culmination of close to a decade of discussion and hard-won compromise by the Gunnison Public Lands Initiative (GPLI) and community to envision a future for local public lands. The Gunnison Country is world class and being out on the land is a way of life for our community. There is also a shared community concern for the future vitality of these lands. The GORP Act is our opportunity to strike an appropriate balance between wilderness, recreational, wildlife, ecological, economic, scientific and cultural values our communities hold dear now and into the future.

The STOR Committee is centered in the Gunnison Valley and works across Gunnison County. At 3,200 square miles, the county is the fifth largest by land area in the state. The County includes approximately 2 million acres of public lands, almost 82% of the total area of the county. The County is home to a National Recreation Area, the mighty Gunnison River, 7 Wilderness Areas, and the Gunnison Field Office of the BLM which manages the popular Hartman Rocks Recreation Area. A new public lands center is under construction, and Western Colorado University based in Gunnison is a hub for environmental management and recreation research that is made possible by the outdoor learning laboratory of public lands here. The University launched a first-of-its-kind Master of Business Administration Outdoor Industry program, which is driving innovation in the industry. Ranching and associated public lands grazing is a legacy that fuels our local economy and culture.

The GORP Act thoughtfully considers these different values and natural amenities that provide for our way of life. Through the work of GPLI, which has crossover representation with the STOR Committee, the Gunnison community has developed a thorough, consensus-driven plan that will help inform how public lands should be managed into the future with a vast array of perspectives. We believe the work of the Board of County Commissioners and GPLI has resulted in a shared vision for public lands management in Gunnison County.

About the STOR Committee

The STOR Committee is a community coalition, created by the Gunnison County Board of Commissioners to improve and maintain tourism and outdoor recreation in a manner that is sustainable (environmentally, socially, and financially) and aligns with community values. Wilderness Workshop has been working to protect the wilderness, water, and wildlife of western Colorado's public lands for nearly sixty years. Our work began with the efforts to double the size of the Maroon Bells-Snowmass Wilderness Area and to designate the West Elks and Raggeds Wilderness Areas, among others. These are some of Colorado's most popular and ecologically-important wilderness areas. The Gunnison Outdoor Resources Protection ("GORP") Act would expand all three of these wilderness areas as well as increase protections for other public lands, providing critical conservation benefits amidst our changing climate and improving recreational opportunities and management.
