A BILL

To amend title XVIII of the Social Security Λct to modernize provisions relating to rural health clinics under Medicare.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Rural Health Clinic
- 5 Burden Reduction Act".
- 6 SEC. 2. MODERNIZING PHYSICIAN, PHYSICIAN ASSISTANT,
- 7 AND NURSE PRACTITIONER UTILIZATION RE-
- 8 QUIREMENTS.
- 9 Section 1861(aa) of the Social Security Act (42

13	rangement consistent with the provisions of State						
14	and local law relative to the practice, performance,						
15	and delivery of health services, with one or more						
16	physician assistants (as defined in paragraph						
17	(5)(A)) or one or more nurse practitioners (as de-						
18	fined in such paragraph).						
19	"(B) PRACTICE AND OVERSIGHT REQUIRE-						
20	MENTS.—The delivery of health services under such						
21	arrangement shall be in accordance with State law						
22	or the State regulatory mechanism governing the						
23	practice of physician assistants or nurse practi-						
24	tioners.".
