## A BILL

- To require the Administrator of the National Oceanic and Atmospheric Administration to establish and maintain a database and webpage that is available to the public and contains information on the billion-dollar disasters that occur each year in the United States, and for other purposes.

- 4 SEC. 2. DATABASE AND WEBPAGE FOR INFORMATION ON
- 5 BILLION-DOLLAR DISASTERS.
- 6 (a) In General.—The Administrator of the Na-
- 7 tional Oceanic and Atmospheric Administration (in this
- 8 section referred to as the "Administrator" shall establish
- 9 and maintain a database and webpage that is available
- 10 to the public and contains information on each billion-dol-
- 11 lar disaster that occurs each year in the United States.
- 12 (b) UPDATE.—Not less frequently than biannually,
- 13 the Administrator shall update the database and webpage
- 14 required under subsection (a) as new information is avail-
- 15 able.
- 16 (c) Matters To Be Included.—The database and
- 17 webpage required under subsection (a) shall include the
- 18 following:
- 19 (1) With respect to each billion-dollar disaster
- included in the database and webpage—
- 21 (A) the estimated cost of the disaster;
- (B) the type of disaster;
- (C) the location of the disaster;
- (D) the date or dates of the disaster; and

1 (E) such other information regarding the 2 disaster as the Administrator considers appro-3 priate. 4 (2) Visual graphs and mapping features show-5 ing the trajectory of disasters over time and the dis-6 tribution of types of disasters across the United 7 States that are similar, if not identical, to those fea-8 tures produced by the National Centers for Environ-9 mental Information from 1980 through 2024 and 10 that were available and updated online 11 www.ncei.noaa.gov/access/billions/ until May 9, 2025. 12 (d) Data to Be Used.—In establishing and maintaining the database required under subsection (a), the Administrator shall use data available to the Adminis-14 15 trator and may collaborate with Federal and non-Federal partners as necessary, such as those partners with which 16 the Administrator collaborated previously while the database specified under subsection (c)(2) was active from 18 1980 through 2024. 19 20 (e) Inclusion of Other Disasters.—The Admin-21 istrator may include in the database required under sub-22 section (a) a disaster that is not a billion-dollar disaster 23 if the Administrator determines that the inclusion of the disaster in the database would be appropriate.

- 1 (f) MAINTENANCE OF EXISTING DATABASE.—The
- 2 Administrator shall maintain and update information con-
- 3 tained in the previously existing disaster database speci-
- 4 fied under subsection (c)(2) on the webpage for the Na-
- 5 tional Centers for Environmental Information for
- 6 archiving and research purposes.
- 7 (g) BILLION-DOLLAR DISASTER DEFINED.—In this
- 8 section, the term "billion-dollar disaster" means a storm
- 9 or severe weather event that results in \$1,000,000,000 or
- 10 more in combined direct costs and market costs as deter-
- 11 mined by the National Centers for Environmental Infor-
- 12 mation.
